## Juried Shows Call for Entries

### Venue:

Juanita K. Hammons Hall for the Performing Arts  
625 John Q. Hammons Parkway  
Springfield, Missouri

### Artist Eligibility:

SVAA juried exhibits are open to any artist 18 years of age or older, living within a 180-mile radius of Springfield.

### Eligible Work:

Entries may be submitted in any medium or combination of media, two or three dimensional. All eligible work must be original--not copied from any other work, not done from an instructional book, and not done under close supervision of any instructor. Eligible work must have been completed in the last three years and may not have been previously shown in any SVAA exhibit at Juanita K. Hammons Hall for the Performing Arts.

All entries must have an **identification tag** attached to the back upper left-hand corner or to the base of three dimensional works. All entries must be of a scale and weight easily handled and installed by SVAA volunteers.

**Two dimensional entries must be framed in a professional manner and equipped with hook eyes and wire.** Sawtooth hangers are not acceptable. Wrap-around canvases are acceptable if edges are completely finished and staples and nails are only visible from the back. Uni-frames are not acceptable.

**Paint** must be dry and stable. **Prints** must have an addition number. **Digitally manipulated photographs** must be identified as such.

SVAA reserves the right to determine the eligibility of any entry based on any criteria deemed appropriate. The final decision as to the eligibility of an entry rests with the SVAA juried shows chairman.

### Sales:

Works may be for sale or not for sale (NFS). SVAA has priority sales rights during the exhibit and will retain a 20% commission from non-members and a 10% commission from members on all sales attributed to the exhibit. The price specified on the entry form cannot be changed during the exhibit.

### Awards:

**Jurors may select up to three works they feel deserve special recognition to receive a cash award of \$50.00.**

### Receipt and Return of Entries:

All entries must be hand delivered to the Fuldner Lounge at the Juanita K. Hammons Hall between 9:00 and 11:00 am on the jury date. **Entries delivered after 11:00 am will not be accepted!** Jurying will be conducted 11:00 am-noon.

Only the juror and SVAA jury volunteers may be present during the jurying process. **Entries not accepted will be returned to artists 1:30-2:30 pm the day of the jury. Artists must return to the jury site during this time or call to see if they have returns.** A phone number to call will be provided when entries are delivered.

### Entry Fees:

**Members:** No fee for one or two entries with membership, fee for a third entry is \$5.00. **Non-members:** For one or two entries, the non-refundable entry fee is \$15.00. **Students:** \$5.00 with a valid student ID.

### Liability:

**Works will be handled with all possible care and diligence. Neither Springfield Visual Arts Alliance nor Juanita K. Hammons Hall for the Performing Arts will be liable for loss or damage from any cause whatsoever. It is recommended that artists acquire personal insurance for their work.**
